Commercial real estate development in Utah is a powerful economic engine, creating jobs and generating significant fiscal contributions to local, state and national economies.

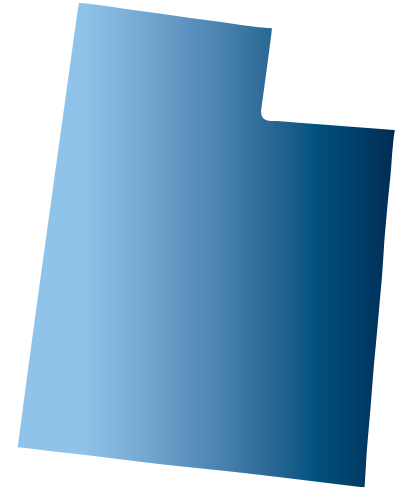
